NOTIFICATION

No.SO (Cab-I)2-30/2013(P).- In exercise of the powers conferred under Article 139 of the Constitution of the Islamic Republic of Pakistan read with rule 49 of the Punjab Government Rules of Business 2011, Governor of the Punjab is pleased to make the following amendments in the Punjab Government Rules of Business 2011, with immediate effect:

AMENDMENTS

In the Punjab Government Rules of Business 2011:

1. In First Schedule:

(a) at Sr. No. 18 [Housing, Urban Development and Public Health Engineering Department], in column 4, under the heading "**Autonomous Bodies & Companies**", after the existing entry at item No. (xxvi), the following shall be inserted:

"(xxvii) Punjab Government Servants Housing Foundation.;" and

(b) at Sr. No. 36 [Services and General Administration Department (including Services, Implementation & Coordination, Regulations and Archives & Libraries Wings)], in column 4, under the heading "**Autonomous Bodies & Companies**", the existing entry at item No. (iii) shall be omitted.

2. In Second Schedule:

(a) under the heading "**HOUSING, URBAN DEVELOPMENT AND PUBLIC HEALTH ENGINEERING DEPARTMENT**", at Sr. No. 14, after the existing entry at item No. v., the following shall be inserted:

"va. The Punjab Government Servants Housing Foundation Act 2004 (X of 2004).;" and

(b) under the heading "**SERVICES AND GENERAL ADMINISTRATION DEPARTMENT**", at Sr. No. 43, the existing entry at item No. xvi. shall be omitted.
